

Our Mission:

To Promote Excellence in Care, Education, Advocacy, and Support.

The Haemophilia Foundation of New Zealand Inc. (HFNZ) is a national voluntary health charity (Charities Commission Registration CC22765). HFNZ was established in 1958 to serve the needs of people with haemophilia and other related bleeding disorders. It is a member of the World Federation of Hemophilia, which is officially recognised by the World Health Organisation.

A bleeding disorder is a health problem that makes it hard for a person to stop bleeding. For blood to clot, the body needs a type of blood cell called platelets, and blood proteins called clotting factors. In people with bleeding disorders, the blood platelets or clotting factors do not work correctly or are in short supply. Severe bleeding disorders are usually diagnosed in infancy as they are caused by an inheritable genetic mutation.

Although medication can help control bleeding and research into better, longer-acting treatment is underway, a cure for haemophilia and other related bleeding disorders remains elusive. HFNZ strives to educate our members and provide support so they are able to live their lives to the fullest. We provide the tools to give our members a voice and try to ensure they receive the best care possible.

Care: HFNZ support the comprehensive healthcare model and continue to work towards ensuring all people with bleeding disorders are able to access the associated services. HFNZ Outreach Workers work alongside clinical teams to ensure that individual healthcare needs are addressed.

Education: Through national workshops for members of all ages, publications, and school visits, HFNZ is able to provide education targeted at the needs of all our members. Our fundraising efforts raise public awareness of bleeding disorders and their consequences. Outreach Workers also work one-on-one with individuals and families to provide personalised education and information.

Advocacy: HFNZ develops advocacy on a personal and national level to help strengthen individuals and our community. At a national level we strive to ensure the security, safety and supply of treatment products and services and on personal level Outreach Workers help members advocate for themselves with a variety of services, from healthcare, to social services to education.

Support: While our Outreach Workers provide individualised support and access to services and beneficial programmes, our regional and national networks provide peer support and social activities, essential in reducing the isolation often felt by having a rare disorder.

President's Report



2012 was both a productive and enjoyable year for the Haemophilia Foundation of New Zealand (HFNZ). I personally enjoyed attending the national events as well as regional meetings, where I gained a sense that our membership is in positive spirits overall. There is also a clear sense of the work ahead to ensure that all people in New Zealand have equal access to a high standard of care and education for their bleeding disorder, irrespective of their geography.

Membership

This report covers the period January to December 2012. As at 31st December 2012, HFNZ represents approximately 1051 individuals with a bleeding disorder. The membership comprises 420 (40%) people with haemophilia A or B, 414 (39%) carriers, 187 with von Willebrand's Disease (18%) and 30 (3%) with a rare bleeding disorder.

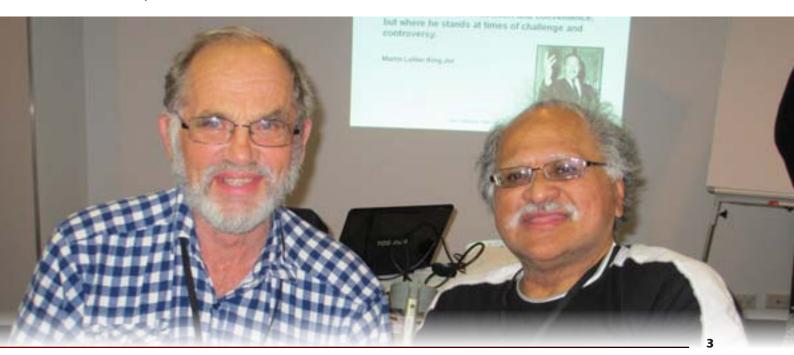
Funding

Affiliated Organisations

Catriona Gordon continued to represent the HFNZ on the National Haemophilia Management Group. This group is responsible for the management of haemophilia services and brings together clinicians, funders, key stakeholders and the HFNZ as the consumer organisation. We thank Catriona for her representation and the management group for their stewardship of services for people with bleeding disorders in New Zealand.

My role on the World Federation of Hemophilia Executive Committee continues until May 2014. I will chair the Funding and Resource Development Committee as well as be a committee member of the National Member Organization Capacity Building, Congress Organising, Educational Materials, Public Relations and Research committees. I look forward to working with these groups in 2013.

National Programmes

In addition to our important Outreach service, the HFNZ provides a number of beneficial programmes to promote the health and wellbeing of our members. The Swimming and Exercise programme supports swimming lessons, therapeutic swimming and access to fitness equipment for people with moderate and severe bleeding disorders.

Every year, the HFNZ runs a range of national programmes to target the needs of our members and deliver our core mission: to support people with bleeding disorders.

• World Haemophilia Day – Children's Education Workshops

17 April, Auckland

In 2012, the World Haemophilia Day was the ideal opportunity to hold the ever popular Children's Education Workshop. This event is targeted towards children aged 6 to 10 years old with a severe bleeding disorder. It was a great day for children to learn the basics of managing a bleeding disorder.

National Men's Workshop

22-24 June, Auckland

The Men's Workshop brought together men aged 25 plus with bleeding disorders for a weekend retreat of education and recreation. The aim is to relax, spend time together and to develop a sense of community while taking part in a number of activities and educational sessions. There is the chance to discuss strategies on living with haemophilia and learn from one another. In 2012, the weekend also featured a special 'Masters' focus meeting for men aged over 45 years to discuss the unique needs they may have as they age with a bleeding disorder, how the HFNZ can help them and what level of representation would best suit them.

The result of the Masters focus meeting was a subsequent gathering in November to further the goals of the group. This group will continue to work together to discuss and share solutions for our aging haemophilia population.

• National New Families Camp

6-9 October – Forest Lakes, Otaki

Held biennially the New Families Camp brings together young families affected by bleeding disorders from all over New Zealand. Parents gain strength through knowledge and understanding, and look to each other for friendship and support. For many children, the camp is the first time that they have been around other children and adults with haemophilia or von Willebrands. This camaraderie provides campers with a sense of togetherness that they are not the only ones with haemophilia and an opportunity to share with others. Children learn about their disorder with fun being core to this learning.

Every year is full of activity for the HFNZ and 2012 has been no exception. I would like to extend my heartfelt thanks to the National Council for their dedication to their voluntary roles in 2012 and, on behalf of the National Council; I wish to thank the staff for their dedication. We all work together for the common cause of sustaining and improving the lives of people with bleeding disorder's and their families in New Zealand.

CEO's Report



Over the past few years the HFNZ membership has been steadily growing. In 2006 we had 701 members and in 2012 the HFNZ database recorded 1051 members. The membership comprises people who either have a bleeding disorder or are carriers of a bleeding disorder.

Outreach Services Benefit Our Community

The HFNZ Outreach service is widely acknowledged as providing valuable support and benefit to HFNZ members and their families. During 2012 the Outreach service nationally maintained an average active caseload of 270 members in each of the four regions.

Contacts with HFNZ members in 2012 were made in the following manner:

- 480 telephone calls
- 474 emails
- 470 face to face meetings
- 369 letters

The contact with members regarded:

- 534 for advocacy and support
- 90 for reproductive queries
- 119 for Hepatitis C
- 180 for vocational guidance
- 446 regarding workshops or camps
- 423 regarding treatment

HFNZ has a series of benefit programmes for our members. Throughout 2012 the following assistance was given:

- 217 for Supportive Footwear
- 307 for Exercise
- 386 for Needs Grant
- 41 for Defensive Driving

2012 Highlights

As well as the educational programmes held in 2012, HFNZ also participated in the following affiliated programmes:

Advance Your Passion

Advance Your Passion (AYP) sponsored by Baxter Healthcare Pty Ltd was a competition where people affected with a bleeding disorder entered by telling the independent judges all about their passion. The winners were awarded their prizes at two events; Connor McQueen and Jack Finn at the June Men's Weekend and Neville-James Reedy and Raukura Riwaka at a Roopu meeting in September.

Step Up Reach Out (SURO)

Step Up Reach Out (SURO) sponsored by Bayer Global, once again saw several Kiwis selected for this international programme. The recipients in 2012 were Kyle Cunningham and Jordan Young. Both young men attended training in San Francisco in 2012 and will complete the programme in 2013 with a visit to Budapest.

The next step after SURO is AFFIRM (Adult Fellowship for Integrating Responsible Mentors). Karl Archibald, who graduated from SURO in 2008, was selected to participate in the program which is intended to help generate the next generation of leaders within the bleeding community. Karl attended AFFIRM in Boulder, Colorado in October 2012.

Asia-Pacific Hemophilia Camp

In July Bayer also funded a weekend haemophilia camp in Seoul, South Korea for young people with haemophilia aged 10 to 17 years. Participants were selected from across the Asia-Pacific region, including two from New Zealand. The lucky recipients of this camp were Connor McCone and Andrew Scott. Both boys were accompanied by their mothers and our own Outreach Worker Linda Dockrill was asked to speak at the camp.

Twins of the Year 2011

In 2012 the HFNZ reached the halfway point through a four year World Federation of Hemophilia (WFH) Hemophilia Organisation Twinning Partnership with the Cambodian Hemophilia Association (CHA). At the WFH World Congress held in Paris during July the success of the partnership was recognised with the HFNZ being awarded the 2011 Twins of the Year. This achievement was made even more special as the HFNZ were the first recipients to receive the award, setting the benchmark for our fellow twins to help to improve the lives of people with bleeding disorders in developing countries. This award puts the spotlight on the HFNZ as a world class organisation, an achievement which is only made possible by the dedication and expertise of the HFNZ staff and the National Council and their passion to help its members. The overall aim of the CHA-HFNZ Twinning Partnership is to build an effective Cambodian Haemophilia Association. The specific objectives of the Twinning Project are:

- To develop skills and knowledge that will enable CHA to operate effectively as an independent, sustainable, self-funded association.
- To assist CHA to develop the capability to manage and implement educational activities and social events for patients and families with bleeding disorders.
- To build a strong sense of community and fellowship within and between the CHA and HFNZ communities.

In 2012 for the first time during the Twinning programme, CHA took control of organising the Twinning Visit agenda. This exciting step demonstrates CHA's progress towards independence and that CHA is developing leadership skills within their association. In November Colleen McKay (Manager – Outreach Services) and Grant Hook (HFNZ Treasurer) visited Siem Riep and Phnom Penh as part of the twinning activities planned by CHA. The 2013 Twinning Visit is expected to take place in August.

It is my privilege to thank the many members I have met during the year – without exception you have been a source of encouragement and inspiration and a continuing reminder to me of what my job is all about.

Lastly I would like to express my gratitude to the HFNZ staff whom once again supported me through a family bereavement in January 2012. Again, it is my privilege to work with such compassionate, supportive and giving people.

HFNZ operates six groups that represent our members, four regional branches (Northern, Midland, Central and Southern), the National Youth Committee (NYC) and He Roopu Tautoko, which represents members who identify as Māori. Each group has their own committee of volunteers who plan and run a number of social activities for the members they represent, continuing the tradition of providing mutual support and connections with other affected families.

Northern Region

The Northern region had a very full and active year in 2012 commencing with the summer family camp and AGM in March. The camp was held in Mangawhai Heads with a view to attracting more attendees from the growing haemophilia community in Northland. As a result the Davis family from Whangarei came on board as committee members. The new venue was enjoyed by everyone who attended and has been booked again for 2013.

Two special High Tea events were arranged for the ladies. One event took place in May at Cornwall Park in Auckland and another was organised by Caroline Davis and held in June in Tutukaka for the Northland ladies. Despite the events being small everyone had a lovely time chatting and connecting.

A trip to Butterfly Creek was repeated in June after the 2011 event proved to be a popular event. More than 40 members gathered with some brave souls attempting and completing the high ropes challenge.

With the assistance of the Roopu committee members, who have family links with Iwi, we arranged a trip to the Waitomo Caves in August. The invitation was extended to Midland members and we were rewarded with a good turnout from both regions.

The Global Feast celebration had a Cambodian theme, in tribute to HFNZ's twinning partner - CHA. We gathered at a Cambodian restaurant in South Auckland and about 20 people enjoyed a sumptuous dinner. The food was plentiful, delicious and beautifully presented. At the end of the evening we were touched when the restaurant proprietor made a cash donation towards the twinning programme.

About 6 volunteers again provided assistance in October over a 3 day period at Armageddon in Auckland. We received a sizeable cash payment for their time and effort.

In November we gathered at a restaurant to surprise Mary Brasser for reaching 20 years as our Haemophilia Specialist Nurse. Many of her former and current colleagues joined a group of people of all ages with haemophilia to celebrate Mary's dedicated "treatment with a smile" over the last 2 decades.

To close 2012 the major event of the year was a Christmas party held at Rainbow's End Amusement Park. It was attended by an all-time record number of people for a Northern event and included some members from Midland. It was a total success!

HFNZ Financial Statements

1. STATEMENT OF ACCOUNTING POLICIES

The financial statements presented here are for the entity The Haemophilia Foundation of New Zealand Inc. The financial statements comprise the National Office and four regional branches.

The accounting principles recognised as appropriate for the measurement and reporting of earnings and financial position on an historical cost basis have been used, with the exception of certain items for which specific accounting policies have been identified.

The Foundation has elected to delay the mandatory adoption of New Zealand equivalents to International Financial Reporting Standards as allowed by the New Zealand Preface. The Foundation qualifies to make this election as it is not subject to the Financial Reporting Act 1993; and is not publicly accountable and not large as defined in the Framework for Differential Reporting.

(a) Changes in Accounting Policies

There have been no changes in accounting policies. All policies have been applied on bases consistent with those used in previous years.

(b) Differential Reporting

The Haemophilia Foundation of New Zealand Inc is a qualifying entity in that it qualifies for Differential Reporting as it is not publicly accountable and it is not large as defined under the Framework for differential reporting.

All differential reporting exemptions have been applied.

(c) Fixed Assets & Depreciation

The entity has the following classes of fixed assets; Office Equipment - 20% Straight Line

All fixed assets are recorded at cost less accumulated depreciation. (d) Goods & Services Tax

These financial statements have been prepared on a GST exclusive basis.

(e) Receivables

Receivables are stated at their estimated realisable value. Bad debts are written off in the year in which they are identified.

(f) Consolidated Financial Statements

The consolidated financial statements include the National Council and regional branches but exclude the Wellington Memorial Haemophilia Trust (disolved during the past financial year), and have been accounted for using the purchase method. All significant interbranch balances have been eliminated on consolidation. No parent entity (the National Council and regional branches) financial statements are prepared because they are not materially different to the consolidated financial statements.

(g) Revenue from Grants

Grant revenue is recognised when the conditions associated with those grants are fulfilled.

2. KIWIFIRST INCOME & EXPENDITURE

The Haemophilia Foundation of New Zealand Inc discloses the following information relating to KiwiFirst income and expenditure.

(i) KiwiFirst Income & Expenses

KiwiFirst income records all monies collected from the public. KiwiFirst expenses record all direct marketing costs and the costs of preparation, publication, printing and distribution of a brochure about haemophilia.

(ii) Expenditure on KiwiFirst

The cost of \$310,172 relates to the assembling, publication, printing and distribution of an information pamphlet on haemophilia produced to inform the public of the disease and to attract people with bleeding disorders in the wider community.

3. CONTINGENT LIABILITIES

At balance date there are no known contingent liabilities (2011:\$0). The Haemophilia Foundation of New Zealand Inc has not granted any securities in respect of liabilities payable by any other party whatsoever.

4. RELATED PARTIES

There were no related party transactions during the year under review.

5. SECURITIES AND GUARANTEES

There was no overdraft as at balance date nor was any facility arranged.

An honoraria payment of \$7,276 was made to the President of the Haemophilia Foundation of NZ (2011: \$5,845). The nature of this payment was to partially compensate the President for loss of earnings for time spent as an executive committee member of the World Federation of Haemophilia.

Expenditure is down by 3.18% on 2011. This is largely attributed to lower fundraising costs for KiwiFirst.

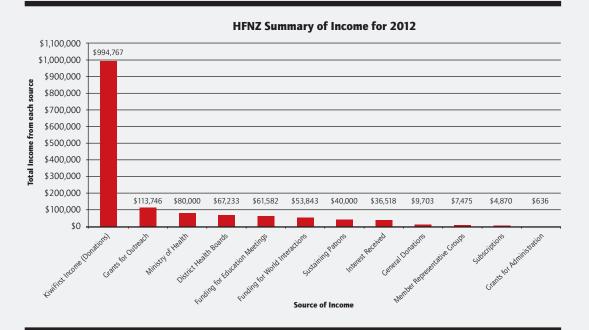
In 2012 HFNZ implemented a new accounting system – XERO. This will enable the financial reporting to be more detailed for analysis by National Council in the future.

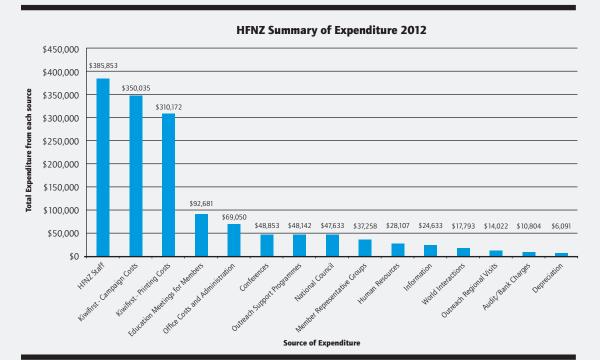

Finances

Again this year earnings have been affected by low interest rates. The end of year result has also been adversely affected by the Trustees responsibility to preserve the Trust's capital and with a higher rate of inflation in 2012 than 2011, an increased inflation reserve has had to be provided for.

The 2012 surplus of \$8,129 (\$3,206 for 2011) is primarily attributable to a grant of \$6,420 from the Wellington Haemophilia Trust, a contribution the Trustees are grateful to receive.

Applicants 2012

For the Year ended 31st December 2012

1. STATEMENT OF ACCOUNTING POLICIES
