Our Mission

To Promote Excellence in Care, Education, Advocacy, and Support.

The Haemophilia Foundation of New Zealand Inc. (HFNZ) is a national voluntary health charity (Charities Commission Registration CC22765). HFNZ was established in 1958 to serve the needs of people with haemophilia and other related bleeding disorders. It is a member of the World Federation of Hemophilia, which is officially recognised by the World Health Organisation.

A bleeding disorder is a health problem that makes it hard for a person to stop bleeding. For blood to clot, the body needs a type of blood cell called platelets, and blood proteins called clotting factors. In people with bleeding disorders, the blood platelets or clotting factors do not work correctly or are in short supply. Severe bleeding disorders are usually diagnosed in infancy as they are caused by an inheritable genetic mutation.

Although medication can help control bleeding and research into better, longer-acting treatment is underway, a cure for haemophilia and other related bleeding disorders remains elusive. HFNZ strives to educate our members and provide support so they are able to live their lives to the fullest. We provide the tools to give our members a voice and try to ensure they receive the best care possible.

Care: HFNZ support the comprehensive healthcare model and continue to work towards ensuring all people with bleeding disorders are able to access associated services. HFNZ Outreach Workers work alongside clinical teams to ensure that individual healthcare needs are addressed.

Education: Through national workshops for members of all ages, publications, and school visits, HFNZ is able to provide education targeted at the needs of all our members. Our fundraising efforts raise public awareness of bleeding disorders and their consequences. Outreach Workers also work one-on-one with individuals and families to provide personalised education and information.

Advocacy: HFNZ develops advocacy on a personal and national level to help strengthen individuals and our community. At a national level we strive to ensure the security, safety and supply of treatment products and services and on personal level, Outreach Workers help members advocate for themselves with a variety of services, from healthcare, to social services to education.

Support: While our Outreach Workers provide individualised support and access to services and beneficial programmes, our regional and national networks provide peer support and social activities - essential in reducing the isolation often felt by having a rare disorder.



Fortunately, there were no serious injuries or fatalities in the immediate haemophilia family but there is ongoing trauma with continuing aftershocks as well as loss. Despite all the difficulties and additional support needed, the usual programmes, camps and publications have continued and are a testament to the strength and resilience of HFNZ and the dedication of staff. I'm proud to be Patron of such an organisation and I congratulate all of you.

The HFNZ was formed over 50 years ago to support, educate and inform people with haemophilia and other bleeding disorders. My own association with haemophilia goes back over 40 years and I have always valued the sense of family that has been engendered. In times of stress this is particularly helpful. Other members of the wider family outside the quake zone have generously offered hospitality and financial support for Cantabrians which has been much appreciated.

The excellent quarterly publication 'Bloodline' keeps us all in touch with HFNZ activities and I was delighted to see that a workshop on Health and Wellbeing included a section on ageing. This addition is a good thing and very appropriate as it reflects the huge advances in haemophilia care. Today a person with haemophilia can expect to have a normal life span - a far cry from expected survival of less than 20 years in the days before treatment was available. Another initiative I was pleased to hear about was the formation of Roopu to increase Māori participation in the organisation.

None of these many activities can take place without the additional contribution of volunteers and the generosity of our donors to whom we owe our heartfelt thanks. HFNZ is in good heart and I look forward to my continuing involvement with this dynamic organisation.





Fig 2: Representation of membership with a bleeding disorder by severity.

Fundraising

Our financial position for the year ending December 31 2011 is detailed on pages 16-18.

As in 2010, the Foundation is mindful of our long-term goal of having a home for haemophilia and contingency fund in place. Lower interest rates have had an impact on our investments. This has been balanced out by the superb fundraising efforts of KiwiFirst and the National Office.

2011 marked a fifteen year relationship with KiwiFirst. KiwiFirst is responsible for generating a large proportion of our fundraising from the New Zealand public as well as providing information and updates about the work of HFNZ. Without this partnership, we would certainly not be able to run the many programmes that we do. As a result of the hard work of KiwiFirst and the generosity of the public, we have individuals and families that contribute financially to our organisation every year.

On behalf of HFNZ, I pass on our heartfelt thanks for the dedication of the team at KiwiFirst. Of course, the success of our fundraising is also closely linked to the generosity of the New Zealand public, so the success of KiwiFirst is also a tribute to the many people from all over the country who have chosen to donate to our cause over many years.

We acknowledge our Sustaining Patrons Baxter, BayerScheringPharma, CSL Bioplasma, NovoNordisk and Pfizer. We also acknowledge funding received from the Ministry of Health in relation to supporting members with Hepatitis C and funding from District Health Boards for part funding of our Outreach Service.

National services

In addition to our crucial Outreach Service, HFNZ provides a number of beneficial programmes to promote the health and wellbeing of our members.

The Swimming and Exercise programme supports swimming lessons, therapeutic swimming and access to fitness equipment for people with moderate and severe bleeding disorders. In 2011, 32 members took part in the programme, helping them build muscle to support their joints and hopefully reduce the risk of bleeding.

A key to reducing the chance of ankle bleeds and longterm joint damage is proper footwear. In 2011, HFNZ supported 70 members in the purchase of supportive footwear.

National activities

HFNZ National Office is located in Christchurch. Despite the many challenges, both physical and emotional that have arising due to the earthquakes, service disruptions and wintry weather, the staff continued to deliver a wide array of national education events in 2011. On behalf of our community, I thank the staff for their dedication to supporting our cause.

> Teen & Youth Camp

> HFNZ National Annual General Meeting

Ed is a haemophilia social worker from Texas who has helped develop both the Parents Empowering Parents programme and the Step Up Reach Out youth leadership programme. Ed gave an inspiring and entertaining talk on engaging, educating and empowering youth.

President's Report

Following the meeting training sessions were held for National Council and also for member representative group committee officers to help refine the goals of the organisation and how practices can help achieve these.

> World Haemophilia Day

17 April is a day to acknowledge how bleeding disorders are part of our lives and raise awareness in the community. This year a number of regional event were hosted around the country to mark World Haemophilia Day, including a trip to Rangitoto Island, celebrations at Waikato and Wellington hospitals and members of the National Youth Committee held a 'Paint it Red' competition.

> Adult Wellness Weekend

A great, well run, wonderful weekend.

Over 50 people attend the Wellness Weekend in Wellington in August. The workshop was specifically for adults with bleeding disorders and partners were also welcomed in recognition of the important role they play.

Australian & New Zealand Inhibitors Workshop

Gaining understanding, empathy, knowledge, and forming new relationships with carers, people with haemophilia, and health professionals has given me better support.

Inhibitors are a serious medical problem that can occur when a person with haemophilia has an immune response to treatment with clotting factor concentrates.

This new educational workshop was developed to help people with haemophilia and inhibitors and their families to better understand and cope with the unique challenges they face. The successful workshop, the first of its kind in the Asia-Pacific region, was an opportunity for individuals and families affected by this reality from Australia and New Zealand to gather, learn and enjoy time together. Participants came from all around Australia and New Zealand and included parents of children with inhibitors, as well as men with inhibitors of all ages and their partners or a support person.

Conferences

> 16th Australia and New Zealand Haemophilia Conference

Held every other year, the 2011 Australia and New Zealand Haemophilia Conference in Sydney was a chance for people with bleeding disorders, their treaters and others in the industry to get together and learn the latest about haemophilia care and support. The conference featured a number of international guest speakers and touched on the intricate network of issues involved with living and treating bleeding disorders. While there were sessions targeted to every sector of the community, there was a special emphasis on wellness and physical wellbeing at every age.

> 7th WFH Global Forum on Safety and Supply

This conference organised by the World Federation of Hemophilia took place in Montreal in September. It focused on three themes facing the global bleeding disorder community: perspectives on risk; achieving a safe and affordable supply of treatment products, and; novel technologies. Held every two years, the global forums have helped build greater understanding of the diversity of circumstances and disparities in access to safe treatment globally and continue to generate important discussion and debate.





Affiliated programs

> Step Up Reach Out

In March, HFNZ were pleased to help host one leg of the Step Up Reach Out (SURO) international youth leadership program for 2010-2011 in Auckland. The programme draws together young men with haemophilia from around the world for leadership skills, personal growth and collaboration.

Later in the year, two previous SURO participants from New Zealand were chosen to be mentors for the programme. Having demonstrated how they haved 'stepped up' at the local level, they travelled to San Francisco to share their experiences.

SURO is administered through the Lonestar Chapter of the National Hemophilia Foundation and funded through a grant from Bayer HealthCare.

> Advance your Passion

Three HFNZ members were chosen as recipients of Advance Your Passion grants in 2011. Advance Your Passion grants are provided by Baxter Healthcare to individuals with bleeding disorders to use to help them develop their passion. The competition is divided into two age groups, those aged 14-21 and those aged over 21 years. Congratulations to Kimberley Drummond to pursue hairdressing, Curtis McQueen to develop his BA Clothing brand and Scott Nelson to pursue an Ocean Yacht Master qualification.

Other representation

> NHMG

HFNZ hold a permanent position on the National Haemophilia Management Group, the group responsible for the planning and funding of haemophilia care across the country.

> World Federation of Hemophilia

In 2011, I continued in my role on the Executive Committee of the WFH, serving the interests of the global haemophilia community. In addition to my role on the Executive Committee I have served on the Research Committee, NMO Capacity-Building Committee and the Educational Materials Committee as the series editor of the Haemophilia Organizational Development series.

Challenges ahead

Haemophilia is a rare congenital condition. It is also a chronic illness and as such creates a complex web of health, family and psychosocial issues for families affected by a bleeding disorder. HFNZ aims to provide programmes, services and support that each of these dimensions and empower our members to be decision-makers of all levels of their treatment and health.

The next year provides us with continuing challenges:

- To work with the our healthcare providers to ensure that the full range of comprehensive care is accessible to all patients;
- To find ways of better meeting the needs of older men with haemophilia, a growing segment of our population; and
- To encourage ongoing participation in the activities of the Foundation (i.e. the committee, support groups, functions etc). HFNZ is only a success through your membership and participation.

Finally, I would like to once again thank all our dedicated staff and volunteers for their work and perseverance across our community.

2011 will forever be remembered in New Zealand history as the year of the devastating Christchurch earthquake. The fact that the National Office is situated in Christchurch made the impact on our organisation all the greater.

The morning of February 22nd was spent looking at potential properties to purchase for a permanent home base for HFNZ. Both buildings viewed that morning no longer exist; such is the nature of change in Christchurch. The purchase of a building for HFNZ has been put on hold by the Council for the foreseeable future as Christchurch grapples with its monumental task of rebuilding a destroyed city.

At the time of the earthquake and its aftermath, HFNZ National Office was situated in what was then the red zone. After a week, as the red zone shrunk in size, we were able to regain access to the office and then the clean up began. Thanks to the staff and some helpful volunteers the office was up and running again in no time. At that stage we had no comprehension of what was in store for us and the rest of the city. Again in June, after another major earthquake, we were temporarily unable to access the building as we waited for the all clear after the building inspection. The office was closed twice more in August as access to town was restricted this time because of snow! Luckily for the staff, when the final major earthquake for 2011 happened on Friday 23 December no one was in the building as we had closed the office for the year on the 22nd!

Our mission statement – to promote excellence in haemophilia care, education, advocacy and support –has remained constant over many years, but how we deliver on the mission has changed over time.

Change for the people of Christchurch was not optional, for all of us living here life is now different and will never be the same as it was.

As we look back and reflect on the highlights of 2011, one thing is certain – what will never change is the desire of HFNZ- its staff and Council- to improve the quality of life for all our members who are affected by a bleeding disorder.

2011 Highlights

Teen & Youth Camp – In January, 24 youth attended an action packed weekend of fun and learning at Camp Adair in the Hunua. This year's theme was 'boot camp', and our boys proved they really have what it takes to meet the challenges of growing up with a bleeding disorder.

Step Up Reach Out Conference is held in New Zealand. Step Up Reach Out, an international leadership programme for youth with haemophilia, held the second leg of their 2010-2011 programme in Auckland in March. Several HFNZ youth have participated in the past and it was honour to be able to host the participants from across the globe.

PEP Train-the-Trainers – Parents Empowering Parents (PEP) is a programme designed to promote effective parenting skills to parents of children with bleeding disorders, and to educate and support them through discussions and exercises. Over 20 parents have participated in the programme, and this seminar was a chance for some of them to learn to present the programme along with haemophilia nurses and outreach workers.

National Adult Wellness Weekend - Following the success of the 2010 workshop, another Wellness Weekend specifically for adults with bleeding disorders and their partners. Over 50 adults attended the weekend in Wellington during August. Speakers covered topics from physiotherapy and arthropathy, to the genetics of haemophilia and the reproduction options, and working with health professionals to get the most of relationships with health care providers.

Australia & New Zealand Inhibitors
Workshop – Inhibitors are considered the biggest
challenge in haemophilia care today. The first ever
educational workshop in Australia and New Zealand
specifically for individuals and families with an
inhibitor to haemophilia treatment was held in Sydney
in September. Twenty-five people, including members
of HFNZ, participated in the workshop facilitated by
HFNZ Manager of Outreach Services Colleen McKay.

2011 provided an opportunity to attend two international haemophilia conferences. The 7th WFH Global Forum* on the Safety & Supply of Treatment products for Bleeding Disorders took place in Montreal, Canada during early September. HFNZ Vice President and Safety & Supply Officer Catriona Gordon and I attended along with members from over 30 other countries. While in Montreal I also attended the World Federation Haemophilia CEO Meeting. Both meetings covered important issues including 'Can we achieve a common decision making a framework for blood safety' and 'Risk based decision making' alongside discussions on 'Gene Transfer'.

As the 16th Australia & New Zealand Haemophilia Conference* was held immediately prior to the Inhibitor workshop in Sydney, a large contingency from New Zealand was represented. The multidisciplinary conference brings together people with bleeding disorders and their families, healthcare workers, industry and HFA and HFNZ staff to discuss best practice on many topics related to bleeding disorders.

In 2011, HFNZ also formally embarked on a 4-year Haemophilia Organisation Twinning (HOT) programme with the fledgling Cambodian Haemophilia Association (CHA) with the goal of assisting CHA to operate effectively as an organisation and build a stronger sense of community. Since our humble beginnings in 1958, HFNZ has grown into a solid, well-

organised and prominent patient organisation. We look forward to working together, sharing our experience and supporting CHA in the years ahead as they begin their journey of bringing people with haemophilia together for education and mutual support.

It should also be noted that this year also marks the 15 year anniversary of KiwiFirst raising valuable funds on HFNZ's behalf. KiwiFirst manages to reach over 100,000 people each year to educate them about bleeding disorders and to raise much needed funds. KiwFirst's efforts are deeply appreciated and gratefully received. Without their help contacting the public, raising awareness of haemophilia and the challenges it brings, and collecting donations, the Foundation's education programmes and member programmes would simply not be possible. Thank you.

Member Representative Group Reports

HFNZ operates six groups that represent our members, four regional branches (Northern, Midland, Central and Southern, the National Youth Committee (NYC) and He Roopu Tautoko, which represents members who identify as Māori. Each group has their own committee of volunteers who plan and run a number of social activities for the members they represent, continuing the tradition of providing mutual support and connections with other affected families.

Roopu

Firstly we pay a special tribute to Joe Wrathall who passed away in February of 2012. Joe confidently laid the foundation for the Roopu and his eagerness was the highlight of his contribution which has inspired the growth of the Roopu. As a roopu we would like to continue with Joe's endeavours for progress and supporting relationships within HFNZ.

The theme for the 2011 Educational Hui was focused on 'Inspirational and Motivation'. This was held in August at Te Kohinga Marama Marae at Waikato University in Hamilton. Our guest speakers included a very talented musician; Te Whainoa Te Wiata spoke on Living with Haemophilia. He is a guitarist for Cornerstone Roots and King Kapisi. Te Whainoa's korero highlighted how his aroha for his whanau is his inspiration for his achievements and his self-care. Raukura Riwaka spoke about the 'H Project' which motivated him to initiate his talent into a purposeful cause where the proceeds raised from the auction of their Weltec class art mural was donated to HFNZ. We were also privileged to have Willie Te Aho who is a motivational speaker and spoke on his achievements, through commitment and perseverance nothing is impossible.

In 1992, at the age of 25 Willie was the youngest Tribal CEO in Aotearoa. He has a MBA from Waikato University and is now CEO for Indigenous Corporate Solutions which focuses on building partnership between corporate organisations (including government) and Maori. He is also a Lead Treaty negotiator for many Iwi claims. Willie also sponsored Raukura with his H Project.

Overall from the whanau who attended, the highlight is always Whanaungatanga (a family being together), listening, sharing, singing and support. As we all reside in different regions of Aotearoa the focus is always 'being together as one' therefore we will continue to look forward to these annual events.



HFNZ Financial Statements

Notes to the Financial Statements - For the Year ended 31st December 2011

1. STATEMENT OF ACCOUNTING POLICIES

The financial statements presented here are for the entity The Haemophilia Foundation of New Zealand Inc. The financial statements comprise the National Office, four regional branches and The Wellington Haemophilia Trust.

The accounting principles recognised as appropriate for the measurement and reporting of earnings and financial position on an historical cost basis have been used, with the exception of certain items for which specific accounting policies have been identified.

The Foundation has elected to delay the mandatory adoption of New Zealand equivalents to International Financial Reporting Standards as allowed by the New Zealand Preface. The Foundation qualifies to make this election as it is not subject to the Financial Reporting Act 1993; and is not publicly accountable and not large as defined in the Framework for Differential Reporting.

(a) Changes in Accounting Policies

There have been no changes in accounting policies. All policies have been applied on bases consistent with those used in previous years.

(b) Differential Reporting

The Haemophilia Foundation of New Zealand Inc is a qualifying entity in that it qualifies for Differential Reporting as it is not publicly accountable and it is not large as defined under the Framework for differential reporting.

All differential reporting exemptions have been applied.

(c) Fixed Assets & Depreciation

The entity has the following classes of fixed assets; Office Equipment - 20% Straight Line All fixed assets are recorded at cost less accumulated depreciation.

(d) Goods & Services Tax

These financial statements have been prepared on a GST exclusive basis.

(e) Receivables

Receivables are stated at their estimated realisable value. Bad debts are written off in the year in which they are identified.

(f) Consolidated Financial Statements

The consolidated financial statements include the National Council and regional branches along with the Wellington Memorial Haemophilia Trust and have been accounted for using the purchase method. All significant interbranch balances have been eliminated on consolidation. No parent entity (the National Council and regional branches) financial statements are prepared because they are not materially different to the consolidated financial statements. Accumulated funds of the in-substance subsidiary (Wellington Memorial Haemophilia Trust) total \$24,255 at year end (2010:\$24,496), and a net surplus/(deficit) of \$(241) was recorded for the year end by the Trust (2010: \$484).

(g) Revenue from Grants

Grant revenue is recognised when the conditions associated with those grants are fulfilled.

2. KIWIFIRST INCOME & EXPENDITURE

The Haemophilia Foundation of New Zealand Inc discloses the following information relating to KiwiFirst income and expenditure.

(i) KiwiFirst Income & Expenses

KiwiFirst income records all monies collected from the public. KiwiFirst expenses record all direct marketing costs and the costs of preparation, publication, printing and distribution of a brochure about haemophilia.

(ii) Expenditure on KiwiFirst

The cost of \$359,902, relates to the assembling, publication, printing, and distribution of an information pamphlet on haemophilia produced to inform the public of the disease and to attract people with bleeding disorders in the wider community.

3. CONTINGENT LIABILITIES

At balance date there are no known contingent liabilities (2010:\$0). The Haemophilia Foundation of New Zealand Inc has not granted any securities in respect of liabilities payable by any other party whatsoever.

4. RELATED PARTIES

There were no related party transactions during the year under review.

5. SECURITIES AND GUARANTEES

There was no overdraft as at balance date nor was any facility arranged.

HFNZ Financial Report

HFNZ has a balance date for annual accounts of 31 December. The following notes are included with the 2011 financial statements and appreciations.

Income and Expenditure

Income is up 19.7% on 2010. KiwiFirst income was up 21.3%. Despite concern the impact of the Canterbury earthquakes would have on fundraising, KiwiFirst had an exceptional year fundraising on HFNZ's behalf.

Expenditure is up 11% on 2010. However, this can largely be attributed to an increase in KiwiFirst expenditure, up by 21% due to the additional efforts and resources needed to raise the increased funds. Other Expenses are \$691,424 and have only increased by 2.3% (2010: \$675,435). Other Expenses includes all costs associated with programmes, administration, staff and member activities. For further breakdown of significant income and expenditure see the graphs and associated tables below.

In the past it has been suggested that a more traditional presentation of information including costs categorised such as electricity, rent, telephone, and travel would be desirable. Instead, HFNZ use a structure that categorises costs into the various programmes conducted by the Foundation. For example, all expenditure associated with costs related with the running of the organisation such as rent, calls, and power are included under Office Costs and Administration. Travel costs are attributed to the appropriate programme or activity the travel was required for. In this way we know what resources are being spent to run, for example, our educational programmes (2011: \$90,499 compared to 2010: \$101,530) or National Council (2011: \$58,931; 2010: \$55,942). This approach gives financial accountability to the way we spend money through our programmes.

The Haemophilia Foundation has a surplus of \$107,402 for the year ended 31 December 2011.



Allan Coster Education Endowment Trust (ACEET)

Finances

The Trust Deed setting up the Trust (1980) required the Trustees to pay grants only from income and to invest the capital in a prudent manner. This year therefore, earnings from interest have again been affected by low interest rates. HFNZ Council has graciously not passed on audit and accounting fees. This has contributed to turning last years deficit of \$2,335 into a surplus of \$3,205 for 2011. This surplus is after allowing for an inflation provision to maintain the Trusts capital sum.

Applicants 2011

In 2011 Trustees continued to make grants to three youngsters benefiting from SPELD tuition during their early years at school. Grants were also paid to assist one applicant toward a double degree.

Instead of last year's eight applicants, in 2011, the Trustees only made grants to three new applicants; one adult for occupational training, one youngster for special needs, and one adult for diploma studies.

Trustees and Procedures

Dr Elizabeth Berry QSO, HFNZ Life Member, Mike Mapperson QSM, HFNZ Life Member, and Mike Carnahan, HFNZ Life Member continued as Trustees.

Trustees rely on HFNZ Haemophilia Outreach Workers to initially determine if an applicant meets the requirements of the Trust Deed and are undertaking current or future study programmes. They each also assemble an application for a grant and assist the individual in making a case to support their application. Without this step in the process the grants procedure would unravel. The Trustees appreciate this input from HFNZ.

Trustees also rely on applicants providing feedback on their outcomes. We continue to be amazed at the workloads taken on by people with bleeding disorders and their high standard of achievement. Undertaking new qualifications along with marriage and a family is not unusual. A double degree at University is also often accomplished; a far step from the days thirty years ago, when a university education could not be contemplated.

Issues to Address

However Trustees do believe there are two important areas requiring attention. We are seeing instances of people with bleeding disorders deciding when in their mid-twenties that their current area of work is proving physically too demanding. Thus forcing a rethink and reselection into a more appropriate career for their next 30 years of working life. We believe this is an area HFNZ Council could well give attention to and explore ways in which career selection might be integrated into existing educational programmes or even a new career programme.

The second issue is repeated incidents where a youngster's fundamental learning needs are not being met by Vote: Education. Usually this is on the grounds that an individual requirement "is not covered by current policy". The outcome becomes a primary school student with two issues to cope with – a bleeding disorder as well as a learning need or difficulty. Often for these children the Trust becomes a final desperate approach for funds – a situation where Trustees find the need is proven, sometimes acute, but not addressed through the education system.

Notes to the Financial Statements - For the Year ended 31st December 2011

1. STATEMENT OF ACCOUNTING POLICIES

The Allan Coster Education Endowment Trust is a Trust. These Financial Statements are general purpose financial statements and have been prepared in accordance with New Zealand generally accepted accounting practices.

The accounting principles recognised as appropriate for the measurement and reporting of earnings and financial position on an historical cost basis have been used, with the exception of certain items for which specific accounting policies have been identified.

The Trust has elected to delay the mandatory adoption of New Zealand equivalents to International Financial Reporting Standards as allowed by the New Zealand Preface. The Trust qualifies to make this election as it is not subject to the Financial Reporting Act 1993, and is not publicly accountable and not large as defined in the Framework for Differential Reporting.

(a) Changes in Accounting Policies

There had been a change in accounting policies in that a Capital Maintenance Reserve has been established to recognise the impact of inflation. The adjustment to the Capital Maintenance Reserve this year is \$2,967 calculated as 1.8% of net assets as at 1 January 2011. The 1.8% increase is based on CPI for the year to 31 December 2011 as published by the Reserve Bank of New Zealand.

There have been no other changes in accounting policies. All policies have been applied on bases consistent with those used in previous years.

(b) Differential Reporting

The Allan Coster Education Endowment Trust is a qualifying entity in that it qualifies for Differential Reporting as it is not publicly accountable and it is not large as defined under the Framework for differential reporting.

All differential reporting exemptions have been applied.

(c) Goods & Services Tax

These financial statements have been prepared inclusive of GST as The Allan Coster Education Endowment Trust is not registered for GST.

2. AUDIT

Audit fees are paid for by the Haemophilia Foundation of New Zealand.

3. CONTINGENT LIABILITIES

At balance date no conditional grants have been approved for payment by the Board of Trustees, for which the terms and conditions for payment had not been met. There are no other known contingent liabilities at balance date (2010:\$Nii).

4. SECURITIES AND GUARANTEES

There was no overdraft as at balance date nor was any facility arranged.
